# A NOTE FROM OUR EXECUTIVE DIRECTOR & BOARD CHAIR

Bounce Animal Rescue had a successful 2018 thanks to its community of animals, volunteers, fosters, and adopters. It was a year of growth, excitement, and adventure (along with a few trials thrown in there). This 3-year organization continues to be a strong and vibrant one that is fun in culture and community.

There were several successes we would like to celebrate:

- 873 animals (mostly dogs) found their new home. These animals were all spayed/neutered prior to adoption, as well as properly vaccinated. All animals were seen by multiple licensed medical professionals.
- A new Facebook page with enhanced social media presence.
- We have broadened relationships with many organizations including PACFA, CFAWA, NoCoRAWC, and several veterinary clinics.
- We have worked to reduce our spay and neuter costs by approximately 30%.
- We have expanded our Board to an excited, working, and active team of 8.

2019 will be a stabilizing year with a lot of innovation:

- An updated strategic plan
- A new website unveiled in April
- A new foster manual and ongoing training
- Involvement with PACFA in rulemaking
- New corporate fundraising and applying for grants
